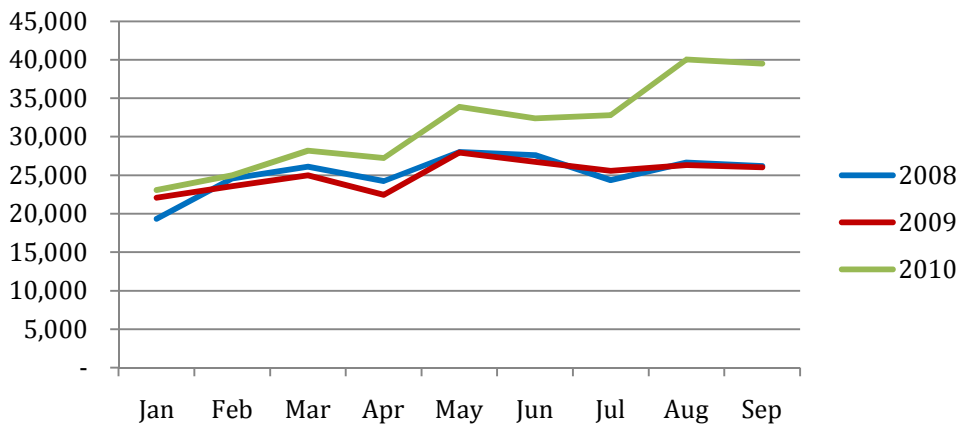




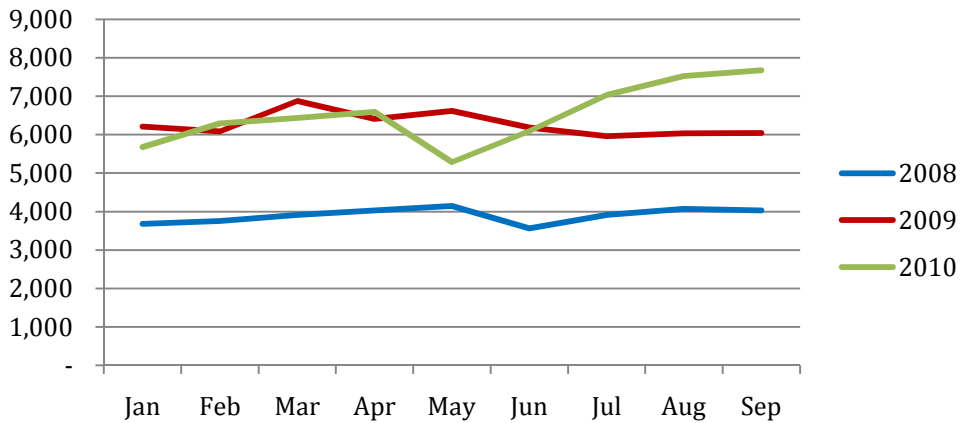
Restaurants - All Locations



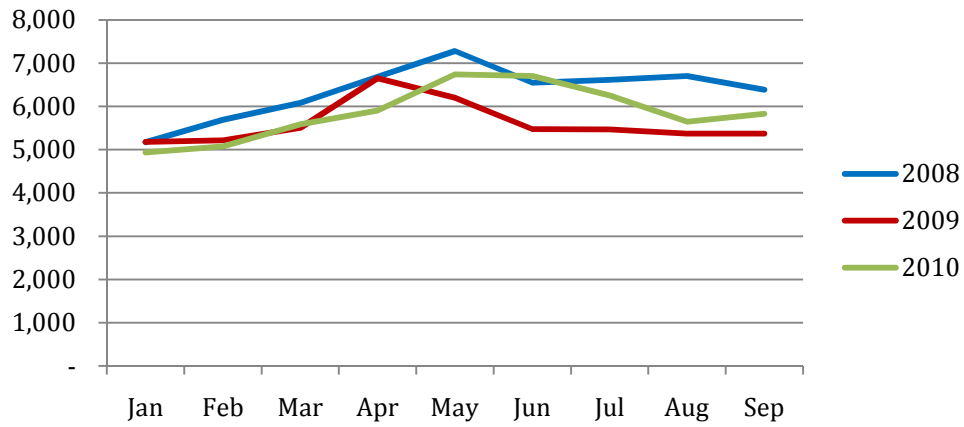

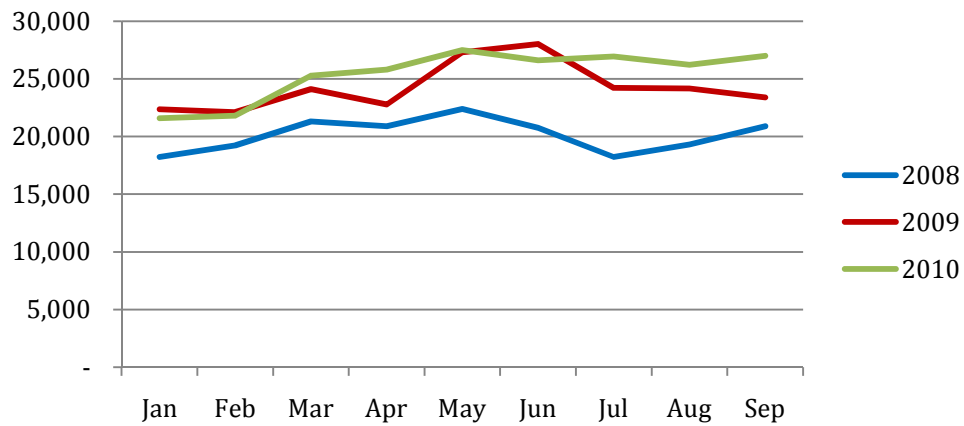

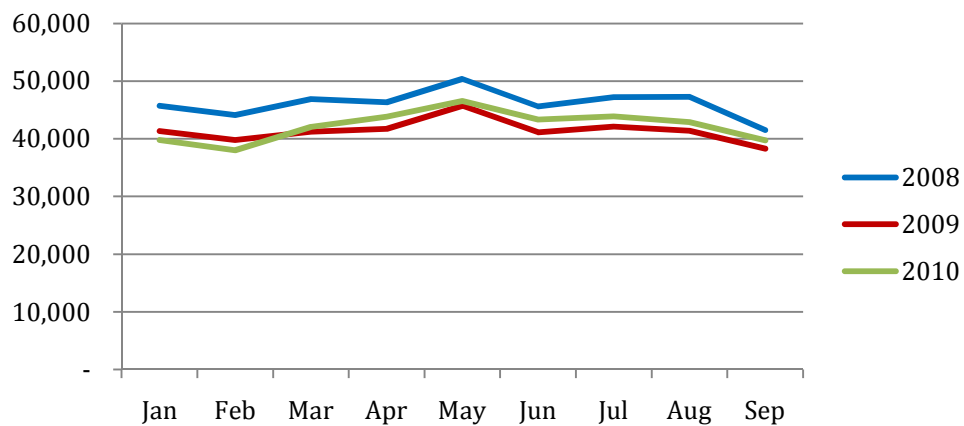
