SUMMARY:

With the election of Mayor Mayor Leh from his Ward I seat to mayor, the City Council now has a vacancy for a Ward I seat.

Per the City Charter, the City Council, by a majority vote of the remaining members, shall appoint a person who meets the qualifications of the position to hold office. The appointee will hold the position until the November 2024 election at which time the person may run for the final year of the term if they choose to.

At the direction of the City Council the Ward I vacancy was opened and advertised from December 8 to January 16. Three qualified residents submitted applications:

- Josh Cooperman
- Gordon Madonna

The Council interviewed all of the applicants on January 30. At the February 6 meeting the Councilmembers will vote and appoint a new member from the applicant pool and they will be sworn in.

Louisville faces several critical issues, namely affordable housing, transit, sustainability, and economic vitality, each requiring focused strategies for resolution.

1. Affordable Housing and Transit: The city's limited affordable housing and transit options are interconnected challenges. The strategy here involves revisiting and updating our outdated zoning policies to promote mixed-use and higher density developments incorporating affordable housing units, while maintaining the charming historic character of our city. We need to create housing for those in serious need and those embedded within the middle-income bracket. A focus on transit-oriented communities can help to improve the overall quality of life in (and maybe existing) developments by reducing traffic and promoting more sustainable transportation.

2. Sustainability: Our commitment to sustainability should be evident in every city initiative. This means investing in renewable energy, sustainable building practices, and community-wide recycling and waste reduction programs. Integrating sustainability into all city planning ensures long-term environmental health and resilience.

3. Economic Vitality: In recent years, Louisville has faced the departure of retail and commercial businesses, creating a perception of being non-business-friendly. To counter this, we must adopt a more proactive approach to retain and attract businesses. This involves the ability to carefully, yet more easily, move new and existing commercial business applicants through the process of approving their investment in our community, offering financial incentives such as sales tax exemption to attract new investment, and actively market Louisville as an attractive location for diverse enterprises. Regular dialogue with business leaders and entrepreneurs will also help identify barriers to business growth and opportunities for city support.

In addressing these issues, a collaborative, inclusive approach is crucial. Engaging with all stakeholders - residents, business owners, city staff, and external experts - ensures that our solutions are well-rounded and effectively address the diverse interests of our community.

Ward I faces unique challenges, particularly in attracting and retaining retail and commercial businesses and altering the perception of decline due to empty storefronts along Main Street.

1. Attracting and Retaining Businesses: A primary strategy to revitalize Ward I is to actively attract and retain both retail and commercial businesses. This can be achieved by simplifying the land use application process to make it easier for businesses to invest in better and more appropriate architecture that supports modern businesses. Additionally, continuing to offer tax relief incentives for new and incoming businesses would make the ward more financially appealing to entrepreneurs and business owners, encouraging them to set up shop in our iconic Downtown.

2. Filling Empty Storefronts: To address the issue of empty storefronts, a multi-pronged approach is necessary. First, we need to make it easier for businesses to invest in Louisville by simplifying and making the land use application process more transparent and friendly. Second, offering financial incentives like tax breaks or reduced lease rates that will ultimately result in increased city revenue streams created by vibrant retail, office and restaurant businesses.

3. Changing Perceptions: The perception of Louisville, and particularly Ward I, as a city with a diminished reputation needs to be urgently addressed. This involves not just filling empty storefronts but also improving the overall aesthetic and appeal of Main Street. Beautification projects, community events, and enhancing local amenities can all contribute to a more vibrant and appealing image. We also need better connectivity on foot and bike to our communities with safe crossing at major roads (South Boulder road, Highway 42). Consistent positive communication about the developments and successes within the ward is also crucial in changing this narrative.

In implementing these strategies, collaboration with local business owners, residents, and other stakeholders is key. Their insights and participation are invaluable in developing effective solutions tailored to the unique needs of Ward I.

Subject: Letter of Recommendation for Tim Bierman to City Council – Ward 1

My name is Michael Boyd and my family and I moved to Louisville six months ago after spending fifteen years in Phoenix, Arizona. My wife and I grew up in a small town outside of Boston and wanted our four-year-old daughter to grow up with some of the same values and benefits that come with small town living (excluding the miserable east coast winters). Moving from a retirement community in the desert, we were looking for a family-oriented town; where kids had all the seasonal activities at their fingertips, if you forgot to lock your door, your neighbors would have an eye on your place and an area where access to different education curriculums were all a short drive away. After countless hours of research, we determined Louisville was where we needed to be.

We packed up our family, our dog and a 53' moving truck and moved sight unseen to a house in old town Louisville. To say we were nervous would be an understatement. We knew nobody, we had only been to the town once and our desire to settle down in our final spot to raise our family was growing. In Arizona, we knew a couple of our neighbors, but being a retirement community, most people tended to keep to themselves. We were hoping this new community would be different and after a short time, it quickly exceeded all of our expectations. Enter Tim.

Tim Bierman, along with his wife Kim and son Grady were the first neighbors we met. Tim came right over to introduce himself and give us his phone number in case we had any questions or needed anything. STATEMENT OF INTEREST

Joshua H. Cooperman

I never envisioned myself becoming involved in government: from a very young age I set my heart on being a scientist, and for some thirty-five years I pursued this aim. Yet this past autumn I found myself campaigning to become Louisville's next mayor. After three years of mounting involvement in Louisville's governance, observing the positive impact that I could effect as an engaged citizen, I decided that I could—and should—amplify my impact by becoming a member of Louisville's government. My journey to running for mayor—and now applying to be appointed a City Council member—started shortly after my family and I moved to Louisville.

We selected Louisville on two bases: my wife's one-evening visit while interviewing for her job and our subsequent online research into the community. Our decision was felicitous: we love living in Louisville. We love Louisville for its welcoming residents, walkable old town, bikeable streets, accessible small businesses, seasonal farmers' market, neighborhood parks, extensive open spaces, system of paths and trails, communal amenities, excellent public schools, and responsible governance. Moreover, we chose to reside in ward 1 so that we could access these features without driving our family car. While Louisville is already a wonderful city, I want to make Louisville an even better place to live, grow, work, recreate, visit, and simply enjoy.

Ever since my childhood I have been interested in, concerned with, and committed to environmental sustainability. While I have long strived to live sustainably and supported environmental organizations, I had never engaged in environmental activism—or activism of any sort. Once my family and I settled in Louisville, I became a much more active champion of environmental sustainability. Three reasons principally motivated this change. First, with my family making Louisville our permanent home, I finally feel fully invested in the community in which I live. Second, as the father of two young girls, I am personally responsible for ensuring that my daughters have a healthy, safe environment in which to not only live, but also thrive. Third, decades of insufficient action to tackle global warming have left us in the midst of a climate crisis. Mitigating climate change had become a personal call to action.

As my involvement in Louisville's governance grew, from an occasional public comment to membership in the Sustainability Advisory Board to regular attendance at City Council meetings, I expanded the scope of my advocacy, activism, and service. Still rooted in environmental sustainability, I began to engage with affordable housing development, diversity, equity, and inclusion initiatives, and gun regulation. I increasingly realized the multitude of issues with which I could help our community, virtually all ultimately resting on the bedrock of environmental sustainability.

Campaigning for mayor reinforced this perception. I knocked as many doors as time permitted, prompting a great many conversations with Louisville residents (and some Louisville business owners). After briefly introducing myself and my priorities, I always inquired after residents' thoughts about, concerns with, and ideas for the City. I listened attentively and respectfully, learning about Louisville's colorful history and diverse perspectives. I came away from many conversations contemplating new ways in which I could work to improve Louisville—as mayor, as a City Council member, or just as an engaged resident.

I could step up my efforts as an engaged resident, continuing to work largely outside of Louisville's government, but the present moment—owing to local, regional, and global circumstances—is a critical juncture for my joining City Council. First and foremost, humanity must urgently work to mitigate climate change at all levels. Second, Louisville is now well-situated to make significant progress on creating affordable housing, the City's consultants having all but completed a housing study, the City's staff having applied for eligibility to receive funds through Proposition 123, and Boulder County residents having approved a shift of sales tax revenue to support such housing. Third, Louisville still has important work to do in recovering from the Marshall fire: beyond welcoming back residents and stitching back together their neighborhoods, Louisville must robustly and responsibly address its wildfire risks. Last, but most certainly not least, Louisville has embarked on the process of updating its Comprehensive Plan, the City's principal guiding document and testament to the community's shared values and vision.

I want to serve now as a City Council member so that I can move Louisville forward at this important time. While I particularly want to lead Louisville's response to the climate crisis, I am fully committed to addressing the City's other priorities: for instance, developing more affordable housing, revitalizing our business sector, safeguarding against wildfires, improving multimodal transportation, and creating a more diverse, equitable, and inclusive community. Indeed, as all of these priorities are interconnected, our actions to mitigate climate change can and must go hand-in-hand with our actions to address these other priorities. I am ready to assume the responsibility and meet the challenge of representing Louisville's first ward as a City Council member.

Supplemental Questions

1) *In your view, what is:*

- *The role of the City Council as a governmental body?*
- *The most important responsibilities you would have as a Councilmember if appointed?*

City Council's role as a governmental body intimately interconnects with City Council members' responsibilities. City Council's primary role is to make decisions on behalf of the City. City Council does not make all decisions for the City: the City's residents democratically elect the City Council members (imbuing the City Council with its decision-making powers), the City's boards and commissions make decisions in certain prescribed circumstances, and, of course, City staff make the vast majority of day-to-day decisions. But, aside from such elections (except in the case of temporary appointments), City Council makes all high-level decisions for City. These decisions—ranging from policy to development to planning—inform the decisions made by the City's residents (for instance, in subsequent elections), the City's boards and commissions, and City staff.

In making decisions City Council members have a great many responsibilities. First and foremost, City Council members have the responsibility of representing their constituents, primarily of their respective wards and secondarily of the whole City. Such representation requires attentive and respectful listening to constituents' concerns, ideas, and perspectives. City Council members also have the responsibility of representing business owners and visitors, again primarily in their respective wards. Equally importantly, City Council members have the responsibility of working towards the City's mission, developed by the City's residents to advance the City's best interests, and planning for the City's future, envisioned in the City's Comprehensive Plan. As part and parcel of such work, City Council members have the responsibility of ensuring that City staff ably and responsibly run the City, most especially, proficiently providing the services on which residents, business owners, and visitors rely. City Council must ultimately ensure that the City runs within its own means, respecting financial, staffing, and other constraints. In all decision making City Council members also have the joint responsibilities of upholding local, state, and federal law and respecting the rights of all relevant individuals and groups. City Council members should also consider regional, national, and global constraints and necessities, historical and socioeconomic contexts, and the wellbeing of the natural world. To ensure equitable and inclusive their decision making, City Council members should be consciously open-minded, thoughtful, and deliberative.

Through its role as a decision-making body, City Council also has the role of overseeing the City's management. City Council members are most certainly not responsible for the City's day-to-day operations, a responsibility that falls to the City manager and staff, but City Council members have the responsibilities of appointing and reviewing the City manager (as well as a few other staff members), providing vision to the City manager, and providing direction to City staff.

City Council has a further role in serving the community—residents, business owners, and visitors—beyond representing them in making decisions: City Council members should assist community members in their interactions with the City. In this role City Council members have the responsibility of acting as impartial intermediaries between community members and City staff, helping both parties to understand their respective positions.

City Council members, especially the mayor, serve one final role: representing the City—its residents, business owners, visitors, and staff—in certain formal and official capacities. In this role City Council members have the responsibilities of comporting themselves with civility and decorum and of accurately and resolutely advocating the City's positions.

2) *In your view, what are the most important issues facing:*

- *Louisville as a city and community and what strategies do you believe will be most effective in addressing them?*
- *Ward I and what strategies do you believe will be most effective in addressing them?*

Louisville faces a variety of important issues including (but not limited to) mitigating and adapting to climate change, creating more affordable housing, revitalizing segments of the commercial sector, continuing to recover from the Marshall fire, mitigating wildfire risks, balancing development with the community's character and expectations, maintain Louisville's high quality of living, and making Louisville a more diverse, equitable, and inclusive community. Within these admittedly broad issues lie more specific issues: for instance, improving multimodal transportation infrastructure and service as part of Louisville's climate change mitigation and high level of service. To limit the length of my response, I briefly address two issues. I touch upon a few of the other issues in the context of ward 1 and in my responses to questions 5, 6, and 7. Furthermore, all of these issues are intimately interconnected not only in their impacts on Louisville, but also in the City's strategies for addressing them. For instance, the Marshall fire, very likely exacerbated by climate change, did not merely displace residents and fracture our community, but also impacted businesses (especially along McCaslin Boulevard), drove increases in rental housing rates, and inequitably affected those rebuilding. While I discuss issues in relative isolation, the City should not address the above issues in isolation.

Climate change is not only an existential threat, but also an immediate threat, and the present moment is the most critical time for mitigation. While climate change is a global issue, its mitigation requires action at all levels: international, national, state, regional, and local. Fortunately, to address climate change in a city like Louisville, mitigation strategies are largely well-established: we must stop emitting greenhouse gases by electrifying all processes that produce such emissions and powering these processes with renewably-generated electricity. Almost all such processes in Louisville—from heating to transportation to manufacturing—can be electrified with current or near-future technologies; accordingly, the crux of climate change mitigation in Louisville is implementation. The City must strive to make implementation as easy as possible for its residents and businesses through education, outreach, and incentives followed in time by regulations and requirements.

Like many municipalities across Colorado and the nation, Louisville desperately needs more affordable housing. In conversations with residents, I have heard a variety of concerns about Louisville's need: some residents are concerned about their ability to remain in Louisville; some residents are concerned about their children's ability to move back to Louisville; some residents are concerned about their ability to downsize in retirement in Louisville; some residents are concerned about the loss of historic homes in old town Louisville; and some residents are concerned about the diminishing diversity amongst their Louisville neighbors. Moreover, some businesses are concerned about their ability to hire and retain employees as many people who work in Louisville, including City staff and public school teachers, cannot afford to live in the community that they serve. Several years ago the City joined a Boulder County-wide effort to increase the County's percentage of affordable housing units to 12% by 2035. Louisville should not only meet, but also embrace its commitment. More affordable housing would benefit Louisville: by addressing the concerns of residents listed above; by making Louisville a more diverse, equitable, and inclusive community; by supporting Louisville's businesses with a larger customer base and employees; and by reducing the environmental impact of people commuting to Louisville. The City should pursue a variety of strategies to create affordable housing, most of which are identified in the City's housing study and many of which are listed on City Council's 2024 work plan. As a basis for creating affordable housing, the City should proactively rezone occupied and vacant commercial zones to mixed-use and residential zones, upzone residential zones to allow accessory dwelling units and multiplexes, and adopt incentive packages for housing developers. To the greatest extent possible, the City should leverage funding available through Proposition 123 and Boulder County Ballot Issue 1B.

Ward 1 faces a variety of its own important issues including (but not limited to) the economic vitality of downtown (and nearby commercial centers), the City's connectedness for pedestrians and bicyclists, and development consistent with the ward's historic and social characters. I briefly address these three issues, touching on some of the City-wide issues mentioned above.

The economic vitality of downtown Louisville, which largely falls within ward 1, has waned in recent years, perhaps most visibly in the several vacant storefronts on Main Street. There are also some nearby vacancies along South Boulder Road, both east and west of Highway 42. A variety of strategies would help to revitalize downtown; I focus on two. First, to generate more foot traffic to support existing and attract future businesses, the City has multiple means at its disposal: encouraging and supporting denser residential development in and near downtown; encouraging bicycle trips to downtown through improved connections, expanded bicycle parking, and electric bicycle charging stations; strategically locating electric vehicle charging stations to attract passing visitors; assisting to reinvigorate the downtown arts scene; and pedestrianizing parts of Main Street. Second, to spur development and redevelopment, the City again has multiple means at its disposal: revising its planning processes to ensure consistency, predictability, and expediency; reexamining its tax incentives and disincentives for existing, renovated, and new properties; activating underutilized properties (like the grain elevator) for new and creative uses; and expanding financial incentives to businesses (contingent on budgetary allowances especially from the Urban Renewal District).

While the portions of ward 1 and ward 3 adjacent to downtown are well-connected for pedestrians and bicyclists, the portions of ward 1 to the north and the other portions of wards 2 and 3 are not so well-connected. South Boulder Road and Highway 42, two of the City's busiest roads run through (and intersect within) ward 1, and Via Appia forms (most of) the western boundary of ward 1. These thoroughfares (and others in wards 2 and 3) create issues for the connectivity of our City, particularly for pedestrians and bicyclists. A well-connected City allows residents to easily visit one another, shop at commercial centers, commute to work or school, and access amenities, all preferably by foot or bike. The City has engaged and continues to engage with improving connectivity across South Boulder Road, Highway 42, and Via Appia, but, despite a few notable exceptions like the underpass just north of Kestrel, the City has not implemented sufficient connections for pedestrians and bicyclists.

While underpasses at the intersections of Via Appia, Main Street, and Highway 42 with South Boulder Road and of South Street with Highway 42 represent the best strategies for addressing this issue, there are more immediate, less costly intersection upgrades that would help to improve connections. The City's recent intersection improvements along South Boulder Road have helped to some extent, but further improvements are warranted. For instance, the intersection of Main Street with South Boulder Road would benefit from an expanded sidewalk on the north, a better bicyclist connection to Steel Street, and a dedicated pedestrian cycle, allowing direct crossing from the north to the southeast or southwest. Marked bicycle lanes—simple, buffered, or advisory—along some of ward 1's busier residential roads (like Main Street, Lafayette Street, Pine Street, and parts of Jefferson Avenue) would also improve connectivity. The plans for Highway 42, which include underpasses, represent a considerable improvement for that roadway (and for crossing that roadway), but the timeline for implementation is relatively long.

Ward 1 is home to many of the Louisville's historic buildings and sites, imbuing this part of our City with a unique character treasured by our community. The interplay between development, especially redevelopment, and historic preservation is thus a key issue for ward 1 (as it has been for quite some years). The City has admirably navigated this interplay, particularly through its historic preservation programs, but the City must remain ever vigilant to preserve its history, tangible and intangible. Many residents favor further preservation, particularly of smaller, older homes and of downtown's character, yet some degree redevelopment is integral to ward 1's economic vitality. To balance these potentially competing interests, the City must maintain its thoughtful navigation, perhaps with strategies like the following two. First, the City should continue to diversify and expand its historic preservation policies and programs, crafting these policies and programs for progress on related issues. For instance, to further disincentivize the destruction of historic buildings, the City could pilot a deconstruction program requiring recycling (rather than allowing demolition and landfilling) of any building meeting certain criteria. Second, the City should consider expanding development opportunities in downtown, especially for housing, while keeping such development more consistent with downtown's historic character, presumably through an updated Old Town Overlay.

3) *As a Councilmember, how would you view your relationships and interactions with each of these groups and how would you hope to be perceived by each of them?*

- a. Residents*
- b. City staff*
- c. Fellow City Councilmembers*

My primary relationship with residents would be serving as their representative on City Council, principally but not exclusively for residents of ward 1. As their representative I would make decisions attempting to integrate their diverse perspectives while upholding local, state, and federal law and protecting the rights of all relevant individual and groups. I would be communicative about City business and responsive to their inquiries. In so serving as their representative, I would hope that residents perceive me as receptive to their ideas and feedback, as an advocate for their preferences, and as constantly working to improve our City.

I would interact with residents individually, for instance, when emailing or meeting with a resident, in small groups, for instance, when Council Dickinson and I host ward 1 forums, and more formally, for instance, when a resident speaks at a City Council meeting. I would also interact with residents as an intermediary between them and City staff. In all of these interactions, I would hope that residents perceive me as being available, accessible, attentive, concerned, nonjudgmental, open-minded, respectful, responsive, and trustworthy. Ultimately, I would hope that residents consider me a valued neighbor and friend.

My primary relationship with City staff would be serving as an advisor in guiding their work. My fellow City Council members and I would primarily advise the City manager, who is charged with conveying this advice to other City staff. Within the established structures of City Council meetings, my fellow City Council members and I would also advise other City staff present. Beyond more formal interactions at City Council meetings, I would interact with City staff at City Council committee meetings and scheduled individual meetings. In serving as an advisor, I would hope that City staff perceive me as engaged with, grateful for, supportive of, and constructively critical of their work, that City staff consider me respectful of their expertise and not overly managerial or supervisory, and that City staff find my feedback, ideas, and questions useful in their work. I would moreover hope to further develop my friendly relationships with City staff.

My primary relationship with fellow City Council members would be serving as their partner in leading the City of Louisville. In this partnership I would hope that our mutual relationships are cordial, collegial, collaborative, open, truthful, respectful, trusting, and productive. I would interact with my fellow City Council members more formally at City Council meetings, less formally at City Council committee meetings, and informally outside of such meetings to progress between meetings and prepare for future meetings (of course, respecting open government rules). In all of these interactions, I would hope that my fellow City Council members perceive me as invested in our community, dedicated to my constituents, clearly communicative, consistently hardworking, supportive of their efforts, constructively critical of their ideas, and principled in my approach, yet willing to compromise.

Louisville is a wonderful community. Our community could further enrich itself in becoming more diverse, equitable, inclusive, and accessible. In a more diverse Louisville residents would reflect a broader range of cultural, social, and economic backgrounds and experiences, more representative of Colorado's population as a whole. In a more equitable Louisville residents would be able to achieve similar ends no matter their backgrounds and experiences. In a more inclusive Louisville residents of all backgrounds and experiences would be welcomed, valued, respected, and celebrated. In a more accessible Louisville residents would not be limited in their choices, engagement, and movement by their diversity of abilities.

The City can—and should—work to so enrich Louisville. City Council took a significant step towards this aim through its Task Force on diversity, equity, and inclusion. Through meetings over the course of a year, this Task Force developed a set of recommended actions: create a safer and more welcoming environment for all, accommodate non-English-speaking populations more thoroughly, provide equitable accommodations and services to all, create a housing market serving people of all socioeconomic situations, engage young residents more effectively, and improve access to public healthcare for all. As recommendations from an engaged and informed resident group, these actions represent the best starting points for City initiatives. The City has indeed begun to implement these recommendations, and as a City Council member I would prioritize further implementation.

Creating more affordable housing likely ranks as one of the most achievable and impactful means for making Louisville a more diverse, equitable, and inclusive community. By overly restricting the City's housing stock and the diversity of this housing stock, Louisville has largely excluded certain socioeconomic segments. By moderately increasing the City's housing stock, especially with a diversity of affordable and attainable units, and by ensuring that some of this housing incorporates accessibility features for certain populations (like seniors), Louisville would become an even more welcoming community. As I mention in my statement of interest and response to question 2, the City is poised to make significant progress on this front.

City Council has other means to make Louisville more diverse, equitable, inclusive, and accessible. First, as the City's EDI manager has begun to advocate, City Council could formally incorporate consideration of diversity, equity, inclusion, and accessibility into its decision-making processes. The Boulder City Council has implemented such procedures. Second, City Council could promote more diverse, equitable, inclusive, and accessible civic engagement by having City communications and materials translated into Spanish. While the City has expanded such translations, and I can only presume that the City intends to further these efforts, City meeting agendas and packets are not translated (as far as I am aware). Translating packets would require significant work, but translating agendas seems an eminently reasonable goal. Such access would serve to better include Spanish-speaking residents in local governance, enabling such residents to advocate for and effect change. Third, City Council could make serving on City Council, boards, and commissions more accessible to a greater diversity of residents through targeted community outreach, availability of childcare, and increased monetary compensation (in the case of City Council). Fourth, City Council could promote socioeconomic equity by making City fees, rates, and fines more progressive and by progressively investing revenues from regressive City taxes. Fifth, City Council could promote equity in and accessibility of transportation by elevating infrastructure and policy for all users to that enjoyed by motorists. Sixth, City Council could leverage the Youth Advisory Board to raise civic awareness and engagement among a greater diversity of young residents. Finally, City Council could enshrine the enrichment of our community through diversity, equity, inclusion, and accessibility as an underlying principle of the City's updated Comprehensive Plan.

6) *What's your vision for our community in ten years' time? How might the upcoming Comprehensive Plan influence that?*

Judging from conversations with residents while campaigning for mayor, almost uniformly, residents are highly satisfied with the current characteristics of the Louisville community. Residents certainly want to see some alterations and improvements and some progress on certain issues, but these changes do not entail marked departures from the community's current character. Over the next decade we should clearly strive to maintain the community's character to a great extent. I firmly believe that Louisville can make significant progress, as envisioned below, while remaining a treasure of a small city. Achieving such ends will require the thoughtfulness that has long characterized our City's governance. As a City Council member I will work to address the issues that our community currently faces while retaining the character that our community so loves. My vision for the next decade entails the progress on a baker's dozen of these issues briefly described below.

First, I envision a reduction in the City's annual carbon footprint of at least 50% and hopefully 75% (compared to the City's highest historical level of annual greenhouse gas emissions). This progress need not—and should not—significantly alter Louisville's existing character: most decarbonization strategies result in replacement of existing technologies with alternatives that achieve the same ends without emitting greenhouse gases and other pollutants.

Second, I envision 10% of the City's housing stock being deed-restricted affordable. Unless Louisville achieves this goal solely by conversion of existing housing—an extremely unlikely prospect—the City's population will increase. While some residents would prefer Louisville not to grow, a measured amount of growth seems completely reasonable and indeed beneficial in many respects; moreover, with careful and thoughtful planning and development, the City can partially mitigate the downsides of growth like increased vehicular traffic.

Third, I envision a revitalized downtown Louisville with filled storefronts, bustling foot traffic, a vibrant arts scene, and an expanded treescape. I foresee some new development, augmenting downtown's historic character through an updated Old Town Overlay's governance and bringing commercial spaces, entertainment venues, and upstairs apartments. I foresee extensive bicycle parking and electric vehicle charging, co-located electric bicycle parking and charging, and the beginnings of commuter rail service, all enabling sustainable transport to and from downtown.

Fourth, I envision the McCaslin corridor reimagined and revitalized as a pedestrian- and bicyclist-friendly mixed-use center. I foresee infrastructure alterations and improvements to vastly improve connectivity for such transportation and new housing on both sides of McCaslin Boulevard occupying existing parking lots and vacant commercial buildings and lots. Beyond downtown and the McCaslin corridor, I even envision satellite commercial centers along South Boulder Road near Annette Brand Park and along 88th Street near the Monarch campus.

Fifth, I envision a Louisville fully recovered from the Marshall fire: all families wishing to rebuild in their new homes, all affected neighborhoods stitched back together, and all of the City well prepared for future emergencies.

Sixth, I envision significant steps towards adapting Louisville to the effects of climate change. Of present and particular concern are Louisville's wildfire risks, heightened by climate change. I foresee the City having implemented well-established wildfire mitigation routines on open spaces, parks, and other landscapes and adopted tailored wildland-urban interface building codes for at-risk properties. I foresee reduction of the City's heat island effect through an appropriately expanded tree canopy, removal of unnecessary and shading of necessary hardscapes, and building and landscaping design alterations. Informed by continuing regional discussions of the Colorado River watershed, I foresee the City planning for and implementing robust water conservation measures.

Seventh, I envision significant improvements to and expansion of Louisville's pedestrian and bicyclist infrastructure, including pedestrian crossings, sidewalk and trail connections, bicycle lanes, bicycle parking, electric bicycle parking and charging, and underpasses, all forming the basis for a substantial increase in the share of trips taken by foot and bike. More specifically, I envision significant progress on Louisville and Lafayette's plans for Highway 42, public transit serving Louisville more extensively, particularly the Colorado Technology Center, Monarch campus, AdventHealth Avista Hospital, and Phillips 66 Rural Special District, and the beginnings of commuter rail service to downtown.

Eighth, I envision significant steps towards better conserving Louisville's native wildlife: expanded restoration of open spaces through programs like the City's pocket prairies; strategic open spaces purchases to preserve high-quality habitat and to extend and establish wildlife corridors; adoption of policies to protect prairie dogs and other wildlife; and large-scale transformation of commercial and residential landscaping to create wildlife habitat throughout the City.

Ninth, I envision a doubling of Louisville's waste diversion rates coupled with a reduction in Louisville's waste production effected by various means: education and outreach, like waste audits at residences and businesses; incentives and policies, like deconstruction in place of demolition; and commercial and regional collaborations, like County-level composting facilities.

Tenth, I envision a Louisville with several of its own multiuse playing fields, several more pickleball courts, its own bike park, and, depending on the degree and location of housing development, plans for a satellite recreational center.

Eleventh, I envision a Louisville that has preserved more of its historic buildings, established a new Old Town Overlay guiding development consistent with its historic character, and reflected more deeply upon its history and prehistory.

Twelfth, I envision a more civically-engaged Louisville. I foresee City Council, boards, commissions, and staff being more diverse and inclusive, City Council and staff leveraging its boards and commissions to accomplish more significant ends, and the City establishing a network for neighborhood outreach modeled on its Marshall fire recovery efforts.

Thirteenth, I envision Louisville developing and adopting modern planning, land-use, and design codes, guidelines, and processes, all emphasizing environmental sustainability, user facility, and transparency.

The City's Comprehensive Plan serves as a guide to the City's development for the decade following its update. The recently-begun process for updating the Comprehensive Plan is thus intimately tied to my vision for our community in ten years' time. As a City Council member I will help to integrate the community's input into an updated Comprehensive Plan that puts forth a vision calling for the progress outlined above.

7) *The City has limited resources, time, and funding. Given that, in what order would you prioritize the following issues for the City Council to address? What other priorities would you add?*

- Implementation of the Citywide Decarbonization Plan
- Filling empty store fronts/office spaces
- Wildfire Mitigation
- Traffic/bicycle/pedestrian safety
- Equity, Diversity, and Inclusion
- Greenhouse Gas Reduction (eliminating gas-powered lawn equipment/electrification infrastructure, etc.)

- Affordable Housing
- Workforce Housing
- Open Space Purchases
- Recreational Amenities
- Open Space/Trail/Park Maintenance

I would prioritize the above issues as follows. I provide a few brief explanations of my prioritization.

1. Greenhouse gas emissions reduction
2. Implementation of the City-wide decarbonization plan
3. Affordable housing creation

I discuss the importance of mitigating climate change and creating affordable housing in my statement of interest and response to question 2.

4. Filling empty storefronts and office spaces
5. Wildfire mitigation
6. Pedestrian, bicyclist, and traffic safety

7. Equity, diversity, and inclusion

The City should consider equity, diversity, and inclusion in all of its actions; in particular, City Council should consider equity, diversity, and inclusion in all of its decision making. The City's EDI manager has begun to advocate for such consideration, and the City has begun to implement the recommendations of the EDI Task Force. Given this progress the issues just above warrant higher prioritization; moreover, addressing some of the above issues, especially affordable housing, will make Louisville more equitable, diverse, and inclusive. City Council can—and should—be ever vigilante in consideration of equity, diversity, and inclusion even without a formal basis for such consideration.

8. Open space, trail, and park maintenance

The City does and should perform adequate maintenance of its open spaces, trails, and parks on a regular basis; such services are a high priority for most residents. The City could improve upon its maintenance, and such improvements could complement the City's approach to issues just above, but the current status of maintenance does not warrant a higher prioritization.

9. Workforce housing

I actively dislike the term 'workforce housing': housing is most fundamentally about providing adequate shelter and more humanistically about creating homes. Most people work in one capacity or another, aside from children and retirees, and all of these people need housing. 'Workforce housing' usually refers, however, to housing for those occupying only certain types of jobs, typically, jobs with compensation inadequate to pay for non-'workforce housing'. I am uncomfortable differentiating homes for people on the basis of their occupations. Nonetheless, I very much support the development of housing in Louisville that allows people who currently work but do not live in Louisville to make Louisville their home.

10. Recreational amenities

While the City has many high-quality recreational amenities, the City would greatly benefit from more of its own multiuse playing fields, more pickleball courts, and a bicycle park. There is particular demand among residents for the first two amenities. As the City's recreational amenities largely meet demand, perhaps with the exception of pickleball courts, developing new recreational amenities does not warrant a higher prioritization.

11. Open space purchases

While I wholeheartedly support future purchases of open space, most especially for the purpose of preserving habitat to stem our epoch's biodiversity losses, I would treat such purchases on the basis of seizing promising opportunities when they arise. The City's expanded open space and parks sales tax will provide a dedicated funding source for such acquisitions; the City, through its Open Space Advisory Board, should keep watch for such opportunities.

I would add to the above list the following issues, which I prioritize with half integers.

- 2.5. Climate change adaptation (tree planting, turf replacement, hardscape removal and shading, water conservation, building and landscaping design codes, etc.)
- 5.5. Adoption of wildland-urban interface building codes
- 6.5. Improved and expanded multimodal transportation infrastructure and service
- 8.5. Senior housing

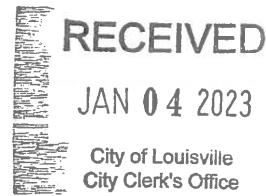
